



BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Deparing Single Ca Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0927 re: Procurement of Chargeable Lights for Emergency Use at the Office, by the Provincial General Services Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P 70,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,
