BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0013, re: Procurement of Various Vegetables Seeds, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 999,986.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEZAR TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of LEZAR TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, LEZAR TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;

- b.) To recommend award to LEZAR TRADING for the delivery of goods under Negotiated Canvass No. 2022-0011 (Emergency Cases), in the amount of P 999,555.50;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
