WHEREAS, the **BOHOL ENVIRONMENT MANAGEMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2022-0024**, re: Procurement of Chainsaw, by the Bohol Environment Management Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of **P 115,000.00;**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


