WHEREAS, the BOHOL ENVIRONMENT MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0024, re: Procurement of Chainsaw, by the Bohol Environment Management Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P 115,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,
