



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL INFORMATION AND MEDIA RELATION</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0054</u> re; <u>Procurement of Ink for High Speed Ink Printer</u>, by the <u>Provincial Information and Media Relation</u>, <u>New Capitol Building</u>, <u>Cogon District</u>, <u>Tagbilaran City</u>, with an ABC of <u>P412,000.00</u>;
