BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-042 re: PROVISION OF CATERING SERVICES DURING THE ADMINISTRATIVE OFFICER'S COORDINATION CONFERENCE FOR CY 2022 with an ABC of ₱ 171, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA</u> <u>GARDEN SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
