WHEREAS, the PROVINCIAL PLANNING DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-043 re: PROVISION OF MEALS & SNACKS DURING THE 2022 PROVINCIAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE MEETINGS FOR 1ST & 2ND QUARTERS with an ABC of \$\mathbf{P}\$ 141, 000.00;
