WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-064 re: PROVISION OF CATERING SERVICES DURING THE VALUES ENRICHMENT PROGRAM (LENTEN RECOLLECTION) with an ABC of P 300, 000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:


