
WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP & 3 MSG ENTERPRISES offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP & 3 MSG ENTERPRISES has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- To declare SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP as the supplier with the Lowest and Responsive Price Quotation for items no. 1, 2, 3, & 6 in the amount of P 538,800.00; while item no. 9 is awarded to 3 MSG ENTERPRISES as the Lowest and Responsive Price Quotation for the Delivery of Goods under Negotiated Canvass No. - PHO - 2020 - 335 (2nd failure of bidding);
- To recommend award SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP for items no. 1, 2, 3, & 6 in the amount of FIVE HUNDRED THIRTY EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (P538,800.00); while item no. 9 is recommend award to 3 MSG ENTERPRISES in the amount of ONE MILLION EIGHT HUNDRED NINETY TWO PESOS ONLY (P 1,892,000.00) for the Delivery of Goods under Negotiated Canvass No. - PHO - 2020 - 335 (2nd failure of bidding);
- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




