BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 401 re: PROCUREMENT OF VARIOUS I.T. EQUIPMENT with an ABC of P 200,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC. has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC. as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 198,016.00 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2021 - 317;
- b.) To recommend award to B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC. in the amount of ONE HUNDRED NINETY EIGHT THOUSAND SIXTEEN PESOS ONLY (P 198,016.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 317;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
