WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0081, re: Procurement of Veterinary Paraphernalia, Drugs & Biologics, Agricultural Supplies, by the Office of the Provincial Veterinarian, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 2,617,250.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEZAR TRADING offered the Lowest price quotation as reflected in the Abstract of Bid Quotations,
