BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u>, <u>NEW CAPITOL BUILDING</u>, <u>COGON DISTRICT</u>, <u>TAGBILARAN CITY</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2022 - 017</u> re: <u>PROCUREMENT OF OFFICE SUPPLIES</u> with an ABC of <u>P 179,922.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PRIM E CONSTRUCTION SUPPLIES</u> <u>TRADING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <a href="PRIM E CONSTRUCTION SUPPLIES TRADING">PRIM E CONSTRUCTION SUPPLIES TRADING</a> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <a href="PRIM E CONSTRUCTION SUPPLIES TRADING">PRIM E CONSTRUCTION SUPPLIES TRADING</a> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 179,380.50 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. PHO 2022 007;

To recommend award to <a href="PRIM E CONSTRUCTION SUPPLIES TRADING">PRIM E CONSTRUCTION SUPPLIES TRADING</a> in the amount of <a href="ONE HUNDRED SEVENTY NINE THOUSAND THREE HUNDRED EIGHTY PESOS AND 50/100 (P 179,380.50)">179,380.50</a>) for the delivery of goods under <a href="Negotiated Canvass No. PHO 2022 007">No. PHO 2022 007</a>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
