WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0841 re; Procurement of Projector, Electric Projector Screen, HDMI Extender, HDMI Cable, CAT 5 Ethernet Cable & RJ45 Connectors, by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 181,450.00;
