WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2021-0892</u>; re; <u>Procurement of Diesel Fuel for Regravelling of Cabanbanan Barangay Road</u>, <u>Dimiao</u>, <u>Bohol</u>, <u>by the Provincial Engineer's Office</u>, <u>New Capitol Compound</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 79,800.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL PROVINCIAL</u>

<u>EMPLOYEES MULTI-PURPOSE COOPERATIVE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
