WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0713 re; Procurement of Communicating Equipment, by the Provincial Disaster Risk Reduction & Management Office, Camp Bernido Compound, Dao District, Tagbilaran City, with an ABC of P 103,870.00;
