



BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL YOUTH & DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-025 re: PROVISION OF MEALS & SNACKS DURING THE CONDUCT OF PSYCHOLOGICAL FIRST AID FOR THE SURVIVORS OF TYPHOON ODETTE IN THE MOST AFFECTED LGUs with an ABC of ₱ 105, 000.00;
