WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0002 re: Procurement of Chainsaw Heavy Duty for Emergency Need in All Provincial Roads Damaged by Typhoon Odette Specifically in PMD 2 & 3, by the Provincial Engineer's Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P 190,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION <u>SUPPLIES TRADING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,
