WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0004; re; Procurement of Communication Device for use in the Information Dissemination on the Programs, Projects & Accomplishments of the Provincial Government of Bohol, as well as Communication of Relevant Updates on Important Matters, by the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 298,500.00;
