**WHEREAS**, the **OFFICE OF THE GOVERNOR**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2022-0004**, re; **Procurement of Communication Device for use in the Information Dissemination on the Programs, Projects & Accomplishments of the Provincial Government of Bohol, as well as Communication of Relevant Updates on Important Matters, by the Office of the Governor, New Capitol Compound, Tagbilaran City.** with an ABC of **P 298,500.00;**

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
