WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0912; re; Procurement of Various Vehicle Spareparts & Oil for the Service Vehicle, by the Provincial Disaster Risk Reduction & Management Office, Camp Bernido Compound, Dao District, Tagbilaran City. with an ABC of P 208,777.00;
