WHEREAS, the OFFICE OF THE VICE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of Consultancy Services under Purchase Request No. 2021-0898 re: Procurement Delivery Receipts, by the Provincial Treasury Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 92,500.00;
