**BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval**

**WHEREAS**, the **OFFICE OF THE PROVINCIAL AGRICULTURIST**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2022-0018**, re: Procurement of Bottom Set Grill Net Fishing (PangMansi) as Part of the Barug Bohol Recovery Effort of PGBh-OPA Brought by OdettePH, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 990,000.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **SUKI TRADING CORP.** offered the Lowest price quotation as reflected in the Abstract of Bid Quotations,
