WHEREAS, the PROVINCIAL ASSESSOR'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0020 re; Procurement of Fuel (Diesel), by the Provincial Assessor's Office, New Capitol Compound, Tagbilaran City, with an ABC of P 66,234.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


