**BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0106 re: Procurement of Various Materials for Generator, by the Provincial General Services Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 798,400.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NODAL ELECTRIC TRADE AND SERVICES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,
