WHEREAS, the PROVINCIAL SOCIAL WELFARE & DEVELOPMENT OFFICE- GO of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-087, re: PROVISION OF CATERING SERVICES FOR RECOVERY AND RELIEF EFFORTS IN RESPONSE TO TYPHOON ODETTE with an ABC of ₱ 900, 000.00;
