

BAC Resolution Declaring SCRQ and Recommending Award

RESOLUTION NO. 2 -OPT_ Series of 2022

WHEREAS, the PROVINCIAL SOCIAL WELFARE & DEVELOPMENT OFFICE- GO of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-087 re: PROVISION OF CATERING SERVICES FOR RECOVERY AND RELIEF EFFORTS IN RESPONSE TO TYPHOON ODETTE with an ABC of P 900, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CASA REV</u> <u>FRANCIS PENSION HOUSE & RESTAURANT</u> offered the single price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.2 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>CASA REY FRANCIS PENSION HOUSE</u> <u>& RESTAURANT</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>CASA REY FRANCIS PENSION HOUSE</u> <u>& RESTAURANT</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- a). To declare <u>CASA REY FRANCIS PENSION HOUSE & RESTAURANT</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> for the <u>CATERING SERVICES</u> under Negotiated Canvass No.22-060(Emergency Cases);
- b). To recommend award to <u>CASA REY FRANCIS PENSION HOUSE & RESTAURANT</u> for the Catering Services of the aforementioned request in the amount of <u>P 900, 000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
