



BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-024 re: PROVISION CATERING SERVICES DURING THE TYPHOON ODETTE VOLUNTEERS/ REPACKERS OF RELIEF GOODS (RICE & CANNED GOODS) FOR THE MONTHS OF FEBRUARY TO MARCH 2022 with an ABC of ₱ 132, 750.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


