

BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procured and Purchase Request No. 2022-048 re: <u>PROVISION OF MEALS AND SNACKS DURING THE BHW GENERAL ASSESSED</u>
<u>DELEGATES & SECRETARIAT</u> with an ABC of ₱ 994,700.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA

GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposale
