



BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2022-0063 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL ENGINEER'S OFFICE** in undertaking Procurement Request under PR No. INF-2021-0123 re: CONCRETING OF POB. SAN ISIDRO ROAD, TALIBON, BOHOL with an ABC of ₱ 1,041,941.88;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **G-RHINO CONSTRUCTION & SUPPLY** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;
