WHEREAS, the PROVINCIAL LEGAL OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0940-re; Procurement of Furnishing of Labor, Materials and Equipment for the Improvement of PLO Conference Room for use at Provincial Legal Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 126,251.08;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
