WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, during the opening of bids on February 16, 2022 the following suppliers DEPENDABLE MANPOWER AND JANITORIAL SERVICES & CYDEM MANPOWER & GENERAL SERVICES, drop its bid proposal for the said procurement;

WHEREAS, in the detailed evaluation of bids DEPENDABLE MANPOWER AND JANITORIAL SERVICES, was declared as the Lowest Calculated Bid as Read in the amount of P 7,681,698.00, and CYDEM MANPOWER & GENERAL SERVICES, has Calculated Bid as Read in the amount of P 7,679,982.06;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, DEPENDABLE MANPOWER AND JANITORIAL SERVICES & CYDEM MANPOWER & GENERAL SERVICES, met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by DEPENDABLE MANPOWER AND JANITORIAL SERVICES & CYDEM MANPOWER & GENERAL SERVICES, the bidder declared as the **LOWEST CALCULATED BID** successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a.) To declare DEPENDABLE MANPOWER AND JANITORIAL SERVICES, as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 2, 4 & 5 in the amount of P 4,252,067.06, and CYDEM MANPOWER & GENERAL SERVICES, as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 1, 3, 6 & 7 in the amount of P 3,427,840.00 for the Provision of **JANITORIAL SERVICES** under Project Reference No. **PHO - 2022 - 002**;
- b.) To recommend award to DEPENDABLE MANPOWER AND JANITORIAL SERVICES, in the contract amount of **FOUR MILLION TWO HUNDRED FIFTY TWO THOUSAND SIXTY SEVEN PESOS AND 06/100 (P 4,252,067.06)**; and CYDEM MANPOWER & GENERAL SERVICES, in the contract amount of **THREE MILLION FOUR HUNDRED TWENTY SEVEN THOUSAND EIGHT HUNDRED FORTY PESOS AND 06/100 (P 3,427,840.00)**;
