BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>TEODORO B. GALAGAR DISTRICT HOSPITAL</u>, <u>JAGNA</u>, <u>BOHOL</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2021 - 346</u> re: <u>PROCUREMENT OF MEDICAL SUPPLIES</u> with an ABC of <u>P 571,150.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>KURTMED MEDICAL</u> <u>DISTRIBUTION INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **KURTMED MEDICAL DISTRIBUTION INC.** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **KURTMED MEDICAL DISTRIBUTION INC.** has been found to be ELIGIBLE and its bid, RESPONSIVE; NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare KURTMED MEDICAL DISTRIBUTION INC. as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 570,922.50 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. PHO 2021 271;
- b.) To recommend award to <u>KURTMED MEDICAL DISTRIBUTION INC.</u> in the amount of <u>FIVE HUNDRED SEVENTY</u>

 <u>THOUSAND NINE HUNDRED TWENTY TWO PESOS AND 50/100 (P 570,922.50)</u> for the delivery of goods under <u>Negotiated Canvass No. PHO 2021 271</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
