



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0071 re: Construction of Reinforced Concrete Box Culvert (Cross Drainage) at Pob. Carmen - Vallehermoso Road, Carmen, Bohol, by the Provincial Engineer's Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P 1,480,756.44

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations:

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE for the delivery of goods/services under Negotiated Canvass No. 2021-0046 (2<sup>ND</sup> FAILURE) in the amount of P 1,477,220.45;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
