BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2021-0071</u> re; <u>Construction of Reinforced Concrete Box Culvert (Cross Drainage) at Pob. Carmen - Vallehermoso Road, Carmen, Bohol, by the Provincial Engineer's Office, Bohol Provincial Capitol, Cogon <u>District, Tagbilaran City, Bohol.</u> with an ABC of <u>P 1,480,756.44</u></u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>INABANGA DRILLING</u>
<u>CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations:

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL Government and the responsiveness of its bid INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2021-0046 (2ND FAILURE);
- b.) To recommend award to INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE for the delivery of goods/services under Negotiated Canvass No. 2021-0046 (2ND FAILURE) in the amount of P 1,477,220.45;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
