WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. _____ series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **TEODORO B. 
WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GOLDEN AI TRADING** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **GOLDEN AI TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b. To recommend award **GOLDEN AI TRADING** in the amount of **FOUR HUNDRED FOURTEEN THOUSAND EIGHT HUNDRED SEVENTY NINE PESOS AND 50/100 (P 414,879.50)** for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2021 - 229 (2nd failure of bidding)**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
