WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0090 & 0066, re; Procurement of Various IT Equipment, by the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 930,912.00
