WHEREAS, the **TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 327 re: PROCUREMENT OF I.T. EQUIPMENT with an ABC of P 100,000.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




