WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-06/ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2021-0908 re; Procurement of Procurement of 4-Cylinder Turbo Intercooler Vehicle for the Use at the Agribusiness Division, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of ₽ 1,995,000.00;
