WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0484 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by Office of the Provincial AGRICULTURIST, in undertaking Procurement Request under PR No. 2021-0462 re; Procurement of Repair, Maintenance & Purchase of Spare Parts, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of ₱ 191,280.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that AGRIMACH CG CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
