WHEREAS, the PROVINCIAL INFORMATION & MEDIA RELATIONS, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0060, re; Procurement of Various IT Equipment for the Rehabilitation & Recovery Efforts to Typhoon Odette, Covid-19 & Provincial Government Programs Monitoring & Update, by the Provincial Information & Media Relations, New Capitol Compound, Tagbilaran City, Bohol. with an ABC of P 374,898.20




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
