WHEREAS, the GO-SPECIAL PROJECT SECTION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0141 re: Procurement Fabric/Streamers, by the Office of the Governor - SPS, Bohol Provincial Capitol, Cogan District, Tagbilaran City, Bohol, with an ABC of P 647,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ADS & PRINTS REPUBLIQ offered the single price quotation among the suppliers as reflected in the Abstract of Bid Quotations,




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
