

BAC Resolution Recommending the Use of Negotiated Progurement Inc. Responsive Quotation and Recommending Approve

WHEREAS, the <u>PROVINCIAL TREASURY OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0157</u> re; <u>Procurement Delivery Receipts</u>, by the Provincial Treasury Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of <u>P 210,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>ST. JUDE PRESS</u>
