BAC Resolution Declaring SCRQ through Agency-to-Agency and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE - SPECIAL PROJECTS SECTION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-085 re: PROVISION OF MEALS AND ACCOMMODATION FOR THE DISASTER PREPAREDNESS & RESILIENCY SEMINAR FOR BARANGAY STAKEHOLDERS with an ABC of P 1,699, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BADIANG SPRING RESORT AND HOTEL offered the single price quotation among the suppliers as reflected in the Abstract of Bids

- To recommend award to BADIANG SPRING RESORT AND HOTEL for the Catering Services of the b). aforementioned request in the amount of P 1,699,000.00;
