

**BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the **OFFICE OF THE GOVERNOR** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0068, re: Procurement for the Rental of Cargo Truck, by the Office of the Governor, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 1,200,000.00;
