## BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_\_series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2021-0529 re; Procurement of CAD Pro Perpetual Licensed & Drone Equipment, by the Provincial Engineer's Office, Bohol Provincial Capitol, Tagbilaran City, Bohol. with an ABC of 2021-0500.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>INFRASYS</u>, <u>INC</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, INFRASYS, INC has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare <u>INFRASYS</u>, <u>INC</u> as the supplier with the <u>Lowest Calculated and Responsive Price Quotation</u> for the Delivery of <u>Goods/Services</u> under Negotiated Canvass No. <u>2022-0006 (2<sup>ND</sup> Failure)</u>;
- b). To recommend award to <u>INFRASYS</u>, <u>INC</u> or delivery of goods/services under Negotiated Canvass No. <u>2022-0006</u> (2nd Failure) in the amount of <u>P 2,170,000.00</u>;
- c) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
