WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL ENGINEER'S OFFICE** in undertaking Procurement Request under PR No. **2021-0529** re: Procurement of CAD Pro Perpetual Licensed & Drone Equipment, by the Provincial Engineer's Office, Bohol Provincial Capitol, Tagbilaran City, Bohol. with an ABC of **₱ 2,175,000.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **INFRASYS, INC** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:
