WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0107 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-010 re: BULK PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 1st QUARTER OF CY 2021 - C. TRAININGS/ SEMINARS/ WORKSHOPS AND CONSULTATIVE MEETING AND OTHER CAPACITY-BUILDING RELATED ACTIVITIES - WITHIN TAGBILARAN with an ABC of P 4, 101, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. for item nos. 1, 4, 7 & 10, PANDA TEA GARDEN SUITES for item nos. 2, 3, 5, 6, 8, 13 & 15, and CASA REY FRANCIS PENSION HOUSE AND RESTAURANT for item nos. 9, 11, 12 & 14 as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC., PANDA TEA GARDEN SUITES and CASA REY FRANCIS PENSION HOUSE AND RESTAURANT have been found to be ELIGIBLE and its bid, RESPONSIVE;

To recommend award REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. in the total amount of P 1, 473, 071.00.00, PANDA TEA GARDEN SUITES in the total amount of P 1, 433, 198.00. and CASA REY FRANCIS PENSION HOUSE AND RESTAURANT in the total amount of P 1, 133, 249.00 for the delivery of Catering and Accommodation Services under Negotiated Canvass No. 2021-029 (2nd Failure);
