

BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LDRQ and Recommending Approval

WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. _____ series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **Garcia Memorial Provincial Hospital, Talibon, Bohol** in undertaking Procurement Request under **PR No. – PHO – 2021 - 274** re: **PROCUREMENT OF MEDICAL SUPPLIES** with an ABC of **P 181,402.50**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BYRO PHARMA CORPORATION** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **BYRO PHARMA CORPORATION** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a. To declare **BYRO PHARMA CORPORATION** as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2022 – 001 (2nd failure of bidding)**;
- b. To recommend award **BYRO PHARMA CORPORATION** for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2022 - 001 (2nd failure of bidding)** in the amount of **ONE HUNDRED EIGHTY ONE THOUSAND THREE HUNDRED NINETEEN PESOS AND 25/100 (P 181,319.25)**.
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
