WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2022-0216 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE** in undertaking Procurement Request under PR No. **2022-C-041** re: **PROCUREMENT OF MEALS DURING THE INTER-AGENCY/LGU COORDINATION MEETINGS, ACTIVITIES ON ENVIRONMENT PROTECTION & CONSERVATION IN THE PROVINCE** with an ABC of **₱ 186, 200.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **CAMANAYON HILL DEVELOPMENT CORPORATION/CHOCOLATE HILLS ADVENTURE PARK (CHAP)** as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **CAMANAYON HILL DEVELOPMENT CORPORATION/CHOCOLATE HILLS ADVENTURE PARK (CHAP)**, have been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare **CAMANAYON HILL DEVELOPMENT CORPORATION/CHOCOLATE HILLS ADVENTURE PARK (CHAP)** as the suppliers with the **Lowest and Responsive Price Proposal** for the Delivery of **Catering Services** under Negotiated Canvass No. **2022-089** (**2nd Failure**);
- b). To recommend award **CAMANAYON HILL DEVELOPMENT CORPORATION/CHOCOLATE HILLS ADVENTURE PARK (CHAP)** in the total amount of **₱ 185, 808.00**, for the delivery of **Catering Services** under Negotiated Canvass No. **2022-089** (**2nd Failure**);
