**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

**WHEREAS**, the **PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2021-0891**, re; **Procurement of 3 in 1 Split Type Air Conditioning Unit with Installation, by the Provincial Enterprise Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City.** with an ABC of **P 194,500.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
